<p>PRACTICES:</p> <ul style="list-style-type: none"> ü MANDATORY - NOT OPTIONAL. Flexibility afforded if a valid excuse & coach is contacted prior to practice. School sport overlap is a valid excuse, but coach needs to be told. Un-excused absence from practices will impact playing time. ü FULL ATTENTION: During drills and instruction, full attention is required & talking minimized. ü EFFORT: Full or best effort is expected. While talent and skill levels vary, effort is universal, Abest effort@ always expected. If full effort is not given, playing time may be impacted. ü BE ON TIME: Practice facility availability is limited. Be prompt and ready to start practice at designated time. <p>DISCIPLINE / BEHAVIOR:</p> <ul style="list-style-type: none"> ü PRACTICE FACILITIES: Any disregard for school or other practice facility property, or defacing or damaging any tournament venue will be cause for immediate expulsion from the team. ü RBA EQUIPMENT: Purposeful damage, defacing, or theft will be cause for immediate expulsion from team. ü RESPECT: Treat all teammates, opponents, officials, and coaches with respect. ü LANGUAGE: Inappropriate language will not be permitted. Warning, reduced playing time, or expulsion if continued after warning will be the remedy. ü FIGHTING/PUNCHES: Zero tolerance. Anyone that throws a punch - at practice or during games - can be expelled from the team. ü GREAT NORTHWEST LEAGUE: Compliance with Great Northwest League rules with regard to behavior is mandatory. I have been provided a copy of the more important rules and will read them prior to the first practice. The most convenient and proximate facilities (to the greatest number of participants) will be utilized. ü TIMES: We are secondary users of school district facilities. As such, inconvenient Abumps@ from scheduled times, etc., may occur. Flexibility is required and parents will be notified as best as possible. Generally, the younger the age of the player, the earlier the practice time. <p>PARENT/COACH INTERFACE:</p> <ul style="list-style-type: none"> ü CONFRONTATION: Coaches Acoach@ and parent role is to support their child and team. Any concerns with and/or suggestions for the coaches are to be made in a respectful manner. Under no circumstances will derogatory comments, coach berating, or argumentative language be tolerated and never in front of children/players. RBA board of directors is proper channel for conflict resolution. Departure from this rule is not permitted and may result in the parent being banned from practice venues and tournaments and/or expulsion of your child from the traveling team without refund. <p>REQUIREMENTS & EXPECTATIONS:</p> <ul style="list-style-type: none"> ü ORIENTATION MEETING: A <u>mandatory</u> orientation meeting for parents and/or guardians will be held by your child-s coaches prior to the first practice. Your child will not participate until attended by at least one parent/guardian. ü HOSTING TOURNAMENTS: 7th and 8th grade parents will (no exception) assist with operation of their child-s home tournament. Sixth grade parents and players will operate the concession stands during their child-s gender 7th and 8th grade tournaments. Girls date is 11/13/10, Boys is 1/29/11. <p>I HAVE READ THE ABOVE REQUIREMENTS AND THE PLAYING TIME NOTICE IN COLUMN 3 OF THE COACH EXPECTATIONS AND AGREE TO ABIDE BY THEM. Playing time is not guaranteed at the 7th and 8th grade levels, but as practical, playing time, based upon player roles, expectations, competition level, attendance, etc., is the expectation. <p>PROGRAM UNITY:</p> <ul style="list-style-type: none"> ü COMMENTS: No inflammatory or derogatory comments regarding any coaches in the RBA family and/or school district will be tolerated. This is a zero tolerance issue. Termination of coaching position is the RBA Board of Director-s remedy. ü COMMUNICATION: Continual and open dialogue with parents and players is expected. Seek out varsity coaches for assistance/insight as may pertain to coaching issues is needed. Consider/acquiesce to varsity coaches with respect to offensive and defensive principles and/or philosophies they may want attempted or implemented. <p>CONDUCT/BEHAVIOR</p> <ul style="list-style-type: none"> ü PLAYER & PARENTS: Players and parents will be treated with dignity and respect. Player berating during practices or game play is not permitted. Team concepts and good sportsmanship must be emphasized. ü GREAT NORTHWEST LEAGUE: Compliance with rules, regulations and requirements of the Great Northwest League is mandatory. I have been provided a set of the GNL rules and will read them prior to the first practice. <p>I HAVE READ THE ABOVE REQUIREMENTS AND AGREE TO ABIDE BY THEM.
